

AGREEMENT FOR THE USE OF THE RALLYCROSS TRACK

This Agreement defines the terms and conditions for the use of the track managed by Hyvinkään Urheiluautoilijat ry (hereinafter HyUA) and the responsibilities of the track user, or their legal guardian, while using the track area.

This Agreement applies to the track area managed by HyUA at Vauhtipuisto, located at Hikiäntie 1508, Hyvinkää, Finland.

TERMS OF USE

1. The track area consists of the starting area, the currently active driving route, and the exit route leading to the pit area.
2. Driving on the track is permitted only during official opening hours and only when a HyUA-appointed track marshal is present. Opening hours are published on HyUA's website at www.hyua.fi.
3. Special caution must be exercised when operating a motor vehicle in the pit or track area. Access to the track is permitted only via the pit area and the starting area. Exiting the track must be done exclusively via the designated exit route. The speed limit in the pit area is 20 km/h.
4. Loading, unloading, and all vehicle maintenance activities are permitted only in the pit area or in another area specifically designated for such purposes.
5. The track user, or their guardian, is responsible for all accompanying persons and pets brought onto the premises.
6. Any vehicle used on the track must have valid statutory motor liability insurance.
7. The consumption of alcohol and the making of open fires are strictly prohibited within the area.
8. Littering is prohibited. All items brought onto the premises must be removed upon departure.
9. While parked in the pit area, the track vehicle must be placed on a liquid-proof pit mat covering at least the entire footprint of the vehicle. In addition, an oil-absorbent mat must be available to prevent oil spills. Any spill or damage must be reported immediately to the track office.
10. The track user, or their guardian, is responsible for their own safety, the safety of their vehicle, and for ensuring that adequate insurance coverage is in place.
11. The track user is responsible for assessing the prevailing track conditions (including, but not limited to, grooves, potholes, standing water, and track edges) and must adapt their driving accordingly.

12. Basic rules for driving on the track:

- 12.1. A maximum of two (2) persons are allowed in a vehicle at any time.
- 12.2. Helmets must be worn at all times and seat belts or safety harnesses must be properly fastened.
- 12.3. All drivers must follow the same designated route. Deviating from the route is permitted only in emergency situations and must be done with extreme caution.
- 12.4. Intentional interference with or harassment of other drivers is strictly prohibited.
- 12.5. Faster drivers must overtake slower drivers cautiously. Slower drivers must allow faster drivers to overtake safely.
- 12.6. The track marshal may separate drivers and/or vehicles into different groups based on skill level or vehicle type and assign separate driving sessions accordingly.
- 12.7. Unmarked obstacles, recovery vehicles, or other equipment may be present on the track and must be passed with caution.
- 12.8. If a hazardous obstacle or other abnormal condition is observed on the track, driving must be stopped immediately, and the track personnel and other drivers must be informed without delay.
- 12.9. A red flag indicates an immediate stop to driving and cautious exit from the track to the pit area.
- 12.10. If driving must be stopped due to, for example, an off-track excursion or technical failure and no personal injuries have occurred, the vehicle must exit the track with great caution or request towing assistance if necessary.
- 12.11. Stopping on the track is prohibited unless personal injury has occurred. In such cases, assistance must be requested and other drivers warned immediately.
13. The pit area must be vacated within 30 minutes of the track closing time.
14. All instructions and directions given by track marshals or HyUA representatives must be followed without exception. Track marshals and HyUA personnel can be identified by their ID cards and have the authority to revoke permission to drive and to require individuals to leave the premises.
15. The track user must pay the applicable track fee or present a valid season pass or free pass before entering the track.
16. The track user, or their guardian, is liable for and obligated to compensate any damage caused by their actions.
17. HyUA shall not be held liable for any damage incurred by track users, their vehicles, or third parties. Payment of the track fee does not transfer any liability for damages or insurance coverage to HyUA or its representatives..
18. HyUA reserves the right to amend or revise the terms of this Agreement at any time.
19. This Agreement is valid until the end of the calendar year in which it is signed..
20. HyUA reserves the right to terminate this Agreement if the track user or their guardian violates the terms of this Agreement or causes danger through their actions.
21. **NOISE LIMIT ON THE TRACK IS 100 dB.** The wastegate pipe must be routed back into the exhaust system. If a vehicle exceeds the noise limit, permission to drive will not be granted. If the noise limit is exceeded during driving, the track marshal may order the driving session to be terminated.

By signing this Agreement, the track user agrees to comply with all rules, instructions, and restrictions governing the use of the track area. If the track user is under 18 years of age, the legal guardian must also sign this Agreement and assumes full responsibility for the actions of the minor, as well as for the individuals referred to in Section 5.
